



Core Case Notification Data Element Recommendations: Immunization History

This document was developed by the Data Standardization Work Group (DSWG) of the Council of State and Territorial Epidemiologists (CSTE) Surveillance Practice and Implementation Subcommittee (SPIS) as part of a larger data harmonization effort. It will be published and maintained in a repository on the CSTE website.

The DSWG identified and standardized the data elements to utilize in the transmission of core surveillance case data to the Centers for Disease Control and Prevention (CDC). Core surveillance data classes and data elements are those that apply across many conditions and, in general, are not specific to any single condition or condition family. In each recommendation document, the DSWG provides common definitions, value sets/code sets, structure, and interpretation notes for each identified data element that is designated as core. The DSWG does not provide questions which would be used to populate the recommended data elements. More information about the DSWG and data harmonization can be found [here](#).

Background

Immunization history data are key to the surveillance of vaccine-preventable diseases. Quality data are important to understand vaccine coverage and inform decision making and public health action nationwide. Public health relies on this information for epidemiologic analyses that inform outbreak response and facilitate a better understanding of the impact of vaccination on disease transmission, severity and outcomes.

Immunization Information Systems (IIS), typically managed and maintained by state or local health departments, are the primary source of immunization records for the residents of a jurisdiction. All IIS are required to record a specific set of data elements that have been endorsed by the CDC in order to meet [IIS Functional Standards](#). These data elements include patient demographic elements such as name, address, and identifiers, as well as vaccination event elements, such as dates, products, providers, and locations pertaining to the specific vaccination event. Some public health agencies have also been successful in establishing varying levels of automation with the data exchange between the IIS and their case-based reportable disease surveillance systems. This facilitates the integration of immunization history from the IIS with cases of vaccine-preventable disease under investigation in the surveillance system. Ultimately, this not only contributes to case investigations, but it also allows for the transmission of more detailed and accurate case information to CDC. At present, not all jurisdictions have this capability that can be resource intensive to establish.

In recent years, a standard set of immunization data elements was developed by the National Center for Immunization and Respiratory Diseases (NCIRD) at CDC for use in applicable condition-specific message mapping guides (MMGs) for the National Notifiable Diseases Surveillance System (NNDSS). This includes a repeating group that captures specific vaccination administrations relevant to each condition and a set of summary-level interpretative vaccine history questions (Table 1). Jurisdictions have different capabilities to capture and send data from their IIS within case notifications, and the intention of the two sets of data elements is to allow jurisdictions to transmit the group of data elements they have the best



capability to collect and transmit. NCIRD has stated that the vaccination history repeating group is preferred for transmission if it is available since it provides detailed vaccine record information for each dose administered.

Core Surveillance Immunization Data Elements for Routine Case Notifications

The data elements below are those that the DSWG recommends defining as core surveillance data for case notifications to the CDC. Data elements marked with an asterisk (*) did not reach the 80% consensus mark within the group but were supported by more than half of the participants. These are included here as core data elements with weak support from the DSWG. For each of the recommended data elements, there is no pre-defined default value for what should be transmitted when the data element has not been populated. Refer to Tables 2-8 below for definitions and additional information for each data element.

It was reiterated by CDC on the DSWG calls that the intention of two sets of data elements is so that jurisdictions can choose to either fill out the Vaccine History Repeating Group or the Interpretive Vaccine History Questions, dependent on local capabilities. During future work on implementation, it may be beneficial to discuss utilizing the data element “Ever Vaccinated Against this Disease” independently of the two sets to allow clear communication for indication that no vaccines were received. More granular vaccination information can be communicated through either the Vaccine History Repeating Group or Interpretive Vaccine History Questions.

The following data elements were also discussed, but the group did not move to include them in core surveillance data for routine case notifications to CDC.

From the Vaccine History Repeating Group:

- Vaccine Dose Number
- Vaccine Lot Number
- Vaccine Expiration Date
- National Drug Code (NDC)
- Vaccination Record Identifier

From the Interpretive Vaccine History Questions:

- Vaccinated Per ACIP Recommendations
- Reasons Not Vaccinated Per ACIP Recommendations
- Vaccine History Comments

The above Vaccine History Repeating Group data elements were not included as core due to concerns about data quality or reliability of these fields within the case surveillance system. The two data elements related to Advisory Committee on Immunization Practices (ACIP) recommendations from the Interpretive Vaccine History Questions were not included as core as it is difficult to apply a consistent interpretation of the recommendations. For instance, an individual may have certain contraindications that would need to be considered as they may alter their recommendation for vaccination. Another struggle with these fields is that the ACIP recommendations can change over time, so determining these fields for adults based on the recommendations at an earlier time can be complicated. The elements Vaccination Record Identifier and Vaccine History Comments raised concerns about the potential for these fields to contain protected health information (PHI).

Several other immunization-related data elements are included in existing MMGs but are only relevant to specific conditions and would be outside the scope of core surveillance data for case notifications to CDC. Such data elements were mentioned briefly during workgroup meetings but not discussed at length in the context of core surveillance data.

Appendix A. Input Data Standards and Data Sources for Immunization Data

Electronic Case Reporting (eCR)

The CDA implementation guide for eCR includes an Immunizations Section (V3) template that communicates a patient's immunization status and immunization history as available within the electronic health record. The Immunizations Section (V3) in turn contains at least one substanceAdministration entry, which is in conformance with the Immunization Activity (V3) template and contains detailed information about each immunization administration. Each substanceAdministration entry can represent either an immunization that has already been received by the patient (moodCode = "EVN" for "event") or an immunization that a clinician intends for the patient to receive (moodCode = "INT" for "intent"). Each entry of substanceAdministration must also contain a statusCode that indicates the current status of the immunization event, where a value of "completed" indicates that the immunization has been completely given.

The eCR CDA implementation guide describes many additional variables that can be included in the substanceAdministration entry to convey various information about the immunization event. The following are examples pertaining to case surveillance:

- effectiveTime: Timestamp representing date/time of administration
- repeatNumber: Number of occurrences
 - Example: A repeatNumber of "3" means that the current administration is the third in a series
- consumable/manufacturedProduct: Represents product information about the immunization substance (i.e., the vaccine)
 - manufacturedMaterial: The vaccine being administered, represented by a CVX code
 - manufacturerOrganization: Vaccine manufacturer

The US Core Immunization Profile in the eCR FHIR specification largely aligns with the Immunization Activity (V3) template in terms of how the data elements are defined and used. It requires that each immunization record that is exchanged according to the specification contains, in addition to patient identification information, the following elements:

- Status: Indicates the current status of the immunization event, where possible values are "Completed", "Entered in Error", and "Not Done".
- Vaccine code: Identifies the kind of vaccine administered, typically using CVX codes, but NDC codes should also be supported as a translation.
- Vaccine administration date: Represents the date/time of the administration.

One element that is defined in the eCR FHIR specification but not in the CDA implementation guide is the primarySource data element, which is a Boolean element that indicates whether the immunization history was captured by the individual/organization that administered the vaccine (value = "true"). A value of "false" indicates that the data are a secondary report of an administration that was performed by a third party.

Electronic Laboratory Reporting (ELR)

ELR does not contain defined data elements related to immunization history.

USCDI and USCDI+

USCDI has contained an Immunizations data class since version 1. As of version 6, this data class includes two data elements: Immunizations, defined as "vaccine product administered, planned, or reported" and Lot Number, defined as "Sequence of characters representing a specific quantity of manufactured material within a batch of a vaccine product.". Two different vocabulary standards must be



supported for the Immunizations data element: CVX – Vaccines Administered and the Vaccine National Drug Code (NDC) Directory. Several other immunization-related data elements, including vaccination administration date, immunization status, and reason immunization not performed, are under consideration (Level 2 or Level 0) for a future version of UCSDI.

The Public Health domain of USCDI+ has adopted four data elements (see Table 9).

Immunization Information Systems (IIS)

To maintain a complete and accurate record of immunizations, IIS must support the bidirectional transmission of immunization data for individuals with healthcare providers that administer vaccinations. Such data are currently exchanged via standards and specifications in the [HL7 Version 2.5.1 Implementation Guide for Immunization Messaging](#). Some public health agencies have also been successful in establishing varying levels of automated data exchange between the IIS and their case-based reportable disease surveillance systems. This facilitates the integration of immunization history from the IIS with cases of vaccine-preventable disease under investigation in the surveillance system. Vaccination event data elements, such as dates, products, providers and locations pertaining to the specific vaccination event can be used to populate relevant fields within a case.
