



Core Case Notification Data Element Recommendations: Industry and Occupation

This document was developed by the Data Standardization Work Group (DSWG) of the Council of State and Territorial Epidemiologists (CSTE) Surveillance Practice and Implementation Subcommittee (SPIS) as a part of a larger data harmonization effort. It will be published and maintained in a repository on the CSTE website.

The DSWG identified and standardized the data elements to utilize in the transmission of core surveillance case data to the Centers for Disease Control and Prevention (CDC). Core surveillance data classes and data elements are those that apply across many conditions and, in general, are not specific to any single condition or condition family. In each recommendation document, the DSWG provides common definitions, value sets/code sets, structure, and interpretation notes for each identified data element that is designated as core. The DSWG does not provide questions which would be used to populate the recommended data elements. More information about the DSWG and data harmonization can be found [here](#).

Background

The Industry and Occupation data class addresses the present and/or past work history of an individual and includes data elements relating to the individual's overall industry and occupation, both current and usual, their employment status and dates, and if they work in specific roles or positions that might be relevant to the condition being investigated. The industry typically refers to the type of business where someone works, such as a hospital, school, or restaurant, while the occupation refers to the type of work a person does, such as a nurse, teacher, or a chef.

Collecting work history as part of case-based surveillance allows for investigation into potential exposures to a condition, may guide the creation of specific work-related prevention messaging for certain conditions, and help identify occupational health inequities. [CSTE Policy Brief 24-PB-EHOH-01 Inclusion of Industry and Occupation as Core Demographic Variables in Public Health Surveillance](#) advocates for the collection and transmission of standardized industry and occupation data.

In recent years, a standard template has been incorporated into condition-specific National Notifiable Diseases Surveillance System (NNDSS) message mapping guides (MMGs) to capture industry and occupation data within case notifications to CDC. This standard template consists of the four data elements listed below (Table 1). Jurisdictions can send both occupation and industry as either a free text field or a standardized code from CDC-developed code systems, which consist of the 2010 U.S. Census Bureau occupation codes and the 2007 U.S. Census Bureau industry codes with modifications made by CDC for unpaid workers and military occupations.

Table 1. Data elements present within the standard template for Industry and Occupation utilized across NNDSS MMGs.

The data elements in the standard template are both associated with CDC Census 2010 value sets. Instead, the National Institute for Occupational Safety and Health (NIOSH) recommends use of the North American Industry Classification Scheme (NAICS) or the Standard Occupational Classification (SOC) value sets for industry and occupation, respectively. The CDC Occupational Data for Health code system, considered to be the applicable vocabulary standard in USCDI, utilizes NAICS for the “Industry NAICS Detail (ODH)” value set and Occupational Information Network (ONET) SOC based codes for the “Occupation ONETSOC Detail (ODH)” value set. The Census codes are intentionally less detailed in order to protect privacy; however, the additional detail as well as the hierarchical nature of the NAICS/SOC value sets adds useful information about relationships between the codes. Furthermore, cross-walking from the NAICS/SOC codes to the Census codes is a simple process that can be undertaken when less detail is deemed necessary.

NIOSH has developed a web-based software tool, the [NIOSH Industry and Occupational Computerized Coding System \(NIOCCS\)](#), designed to translate industry and occupation free text into standardized industry and occupation codes. In addition to utilization of the autocoder through an API being much faster than manual coding, it allows for greater consistency in code mapping and can output either Census, NAICS, or SOC codes as desired. However, implementation of this tool varies greatly across PHAs, and therefore, “Current Industry Standardized” and “Current Occupation Standardized” are often not available in jurisdiction surveillance systems or to transmit to CDC.

In addition to the standard Industry/Occupation template used in many MMGs, other data elements relevant to this data class have been included in condition-specific MMGs. For example, data elements such as “Case Patient a Healthcare Worker”, “Day Care Worker Within 7 Days Before Illness” and “Food Handler” are aiming to determine if the person had a potential occupation-related exposure. In some communicable disease scenarios, these data elements may also provide information for public health action and infection control when a case has been identified in a specific work setting or work location.

Core Surveillance Industry and Occupation Data Elements for Routine Case Notifications

The data elements below are those that the DSWG agreed to define as core surveillance data for case notifications to CDC. For each of these data elements, there is no pre-defined default value for what should be transmitted when the data element has not been populated. Refer to Tables 2-6 below for definitions and additional information for each data element.

Discussion occurred around the use of the term “current” within these definitions. Options considered included specifying “current” as a date associated with the case, the exposure period for the case, or a more general time of event. Ultimately the group decision was to leave the definitions as simply “current” as these data elements are more demographic-level than case-related, can be abstracted from eCR if “current” is not defined in a potentially conflicting way, and defining further was seen as adding too much complexity when trying to meet all potential use cases. A data element to capture whether exposure to the condition is related to the current occupation was also discussed, but this concept will be considered as a part of the Exposure/Risk Factor data class conversation.

The first four data elements are commonly utilized within MMGs currently as a repeating group to capture as many instances of employment as needed. The standardized elements utilizing coded value sets are preferred if the jurisdiction is able to use the NIOCCS autocoder. Free text data elements are available when the autocoder is unable to be used. The additional Current Employment Status is a standalone data element separate from a repeating group that helps to convey if someone is unemployed or not in the labor force, as a lack of data within Current Industry/Occupation does not convey whether the information is unknown or if the person is unemployed/not in the labor force. Current Employment Status can also assist with analyses into how the presence or absence of employment may correlate with health outcomes.

Interpretation Notes

[NIOSH's Technical Report "A Guide to the Collection of Occupational Data for Health: Tips for Health IT Systems Developers"](#) specifies that this data element conveys information about someone's potential financial resources, benefits, and demands which can impact their health. It is not intended to capture the type of work someone is engaged in (e.g., full-time, part-time, work from home). Volunteer work would not be considered "Employed", but information on the type of volunteer work someone does may still be captured in Current Industry and Current Occupation: the recommendations specify that volunteer work should be included in Current Industry and Current Occupation if the volunteer work is as an emergency/first responder, or if the volunteer work is at least 20 hours/week.
